


Model with 2 half doors


















Model with 1 door remote unit








Model with 2 doors remote unit












Model 2 half doors remote unit














Model with 2 doors – CO2 remote unit with valve




Model with 1 door – CO2 remote unit without valve




Model with 2 doors – CO2 remote unit without valve





#### A.4 General safety

- The appliances are provided with electric and/or mechanical safety devices for protecting workers and the appliance itself.
- Never operate the appliance, removing, modifying or tampering with the guards, protection or safety devices.
- Do not make any modifications to the parts supplied with the appliance.
- Several illustrations in the manual show the appliance, or parts of it, without guards or with guards removed. This is purely for explanatory purposes. Do not use the appliance without the guards or with the protection devices deactivated.



Disconnect the appliance from the power supply before carrying out any installation, assembly, cleaning or maintenance procedure.

- Do not remove, tamper with or make illegible the marking and safety, danger and instruction signs and labels on the appliance.
- The A-weighted emission sound pressure level does not exceed 70 dB(A).<sup>1</sup>
- · Carefully avoid exposure of the equipment to ozone do not use ozonizers in the rooms where the equipment is installed.
- The following operations have to be carried out by specialised authorised personnel or Customer Care Service provided with all the appropriate personal protection equipment (A.3 *Personal protection equipment*), tools, utensils and ancillary means, who can ask the manufacturer to supply a servicing manual:

## A.6 Residual risks

The appliance has several risks that were not completely eliminated from a design standpoint or with the installation of adequate protection devices. Nevertheless, through this manual the Manufacturer has taken steps to inform operators of such risks, carefully indicating the personal protection equipment to be used by them. In order to reduce the risks, provide for sufficient spaces while installing the unit.

To preserve these conditions, the areas around the appliance must always be:

- kept free of obstacles (e.g. ladders, tools, containers, boxes, etc.);
- clean and dry;
- well lit.

For the Customer's complete information, the residual risks remaining on the appliance are indicated below: such actions are deemed improper and therefore strictly forbidden.

Residual risk	Description of hazardous situation
Slipping or falling	The operator can slip due to water, any liquid or dirt on the floor
Burns/abrasions (e.g. heating elements, cold pan, cooling circuit plates and pipes)	The operator deliberately or unintentionally touches some components inside the appliance without using protective gloves.
Electrocution	Contact with live parts during maintenance operations carried out with the electrical panel powered
Falling from above	The operator intervenes on the appliance using unsuitable systems to access the upper part (e.g. rung ladders, or climbs on it)
Crushing or injury	The specialised personnel may not correctly fix the control panel when accessing the technical compartment. The panel could close suddenly.
Tipping of loads	When handling the appliance or the packing containing it, using unsuitable lifting systems or accessories or with the unbalanced load
Chemical (refrigerant gas)	Inhalation of refrigerant gas. Therefore always refer to the appliance labels
Sudden closure	The operator for normal appliance use could suddenly and deliberately close the door/drawers (if present, depending on the appliance type).

## A.7 Technical data

- The data plate and the energy labelling refer to original manufactured configuration.
- The appliance that can operate at 50 Hz or 60 Hz does not need any setting by the user.

#### Materials and fluids used

- R290 gas is potentially flammable and explosive. Take every possible precaution to prevent any risk linked to the nature of this
  gas during any routine and/or extraordinary operation carried out on the appliance.
- In appliances using R-744 as refrigerant, the design pressure is 14 MPa (140 bar).
   WARNING: the refrigeration system is under high side pressure. Do not tamper with it. Contact qualified service personnel before disposal.

- 43°C (IEC/EN 60335-2-89)
- 25°C room with 60% relative humidity (EN 16825/EN ISO 22041).

#### A.9 Transport, handling and storage

- Transport (i.e. transfer of the machine from one place to another) and handling (i.e. transfer inside workplaces) must occur with the use of special and adequate means.
- Do not stand under suspended loads during loading or unloading operations. Unauthorized personnel must not enter the work area.
- The weight of the appliance alone is not sufficient to keep it steady.
- · For machine lifting and anchoring, do not use movable or weak parts such as: casings, electrical raceways, pneumatic parts, etc.
- Do not push or pull the machine to move it, as it may tip over. Use proper tool to lift the machine.
- Arrange a suitable area with flat floor for machine unloading and storage operations.
- Machine transport, handling and storage personnel must be adequately instructed and trained regarding the safely use of lifting
  systems and personal protection equipment suitable for the type of operation carried out.

#### A.10 Installation and assembly

- The installer must evaluate the minimum volume of the installation's environment necessary to reduce the risks related to danger caused by the flammability and toxicity of the refrigerant present in the appliance.
- The operations described must be carried out in compliance with the current safety regulations and provisions in force in the country of use.
- The appliance is not suitable for installation outdoors and/or in places exposed to atmospheric agents (rain, direct sunlight, etc.).

#### A.11 Electrical connection

- The power supply system must be suitable for the rated current of the connected appliance; the connection must be carried out in compliance with the regulations and provisions in force in the country of use.
- For appliances with remote unit, the connection must be made separately for the unit and the appliance.
- The information regarding the appliance power supply voltage and frequency is given on the data plate.
- Install between the power cable and the electric line a differential thermal-magnetic switch suitable for the absorption specified on the data plate, with contact gap enabling complete disconnection in category III overvoltage conditions and complying with the regulations in force.

For the correct sizing of the switch or plug, refer to the absorbed current specified on the appliance data plate.

- After making the connection, with the appliance running check that the power supply does not fluctuate by ±10% the rated voltage.
- With models arranged for operation without incorporated refrigerating system, carry out the condensing unit and solenoid valve
  electrical connections as shown in the wiring diagram accompanying the appliance. The connection must be made with a cable
  of suitable section. Insert and secure the cables with the special cable clamp. Correctly connect each wire to the corresponding
  terminal.
- If the power cable is damaged or too short, it must be replaced by the Customer Care Service or in any case by specialised personnel, in order to prevent any risk.
- The manufacturer declines any liability for damage or injury resulting from breach of the above rules or non-compliance with the electrical safety regulations in force in the country where the appliance is used.

#### A.12 Maximum impedance permitted

#### A.13 Electrical connection for appliances with plug

• To connect to the power supply, insert the power cable plug in the corresponding mains socket, first making sure:

- the socket has an efficient earth contact and the mains voltage and frequency match that given on the dataplate. In case of any doubts regarding the efficiency of the earth connection have the system checked by specialised personnel.

 the system power supply is arranged and able to take the actual current absorption and that it is correctly executed according to the regulations in force in the country of use.

- The plug must be accessible after positioning the appliance in the place of installation.
- The plug must be in a position always visible to the operator performing the intervention during maintenance operations.

#### A.14 Electrical connection for appliances with cable without plug

- The connection point has an efficient earth contact and the mains voltage and frequency match that given on the data plate. In case of doubts regarding the efficiency of the earth wire, have the system checked by specialised personnel.
- The appliance must be permanently connected to the power supply, respecting the polarities:
  - brown/black<sup>2</sup>/gray<sup>2</sup>: phase
  - yellow/green: earth
  - blue: neutral
- An H05VV-F type power cable (code 60227 IEC 53) is used for the permanent connection to the mains; in case of replacement, use a type with at least these characteristics. When replacing the cable, the earth wire must be kept longer than the live and neutral wires.
- The differential thermal-magnetic switch must be lockable in the open position in case of maintenance.
- If using a plug, it must comply with the national installation rules. The plug must also be:
  - accessible after the appliance has been positioned
  - in the place of installation;
  - in a position always visible to the operator performing the intervention during maintenance operations;

#### A.15 Positioning

 Install the appliances, taking all the safety precautions required for this type of operation, also respecting the relevant fireprevention measures.

2. present only in appliances with three-phase power supply

- For the choice of remote condensing unit refer to the unit recommended by the Manufacturer, given on the equipment technical sheet.
- In case of extraordinary size of the remote condensing unit refer to the technical sheet for the refrigerating capacity data or consult the Manufacturer's website or Local Service Center/ Agency authorized by the Manufacturer.
- In appliance with R-744 as refrigerant, a pressure relief device shall be installed in the high pressure side of the refrigeration system between the motor-compressor and the gas cooler. There shall be shut off devices or other components except piping between the motor-compressor and the pressure relief device that could introduce a pressure drop.
- The pressure relief device shall be mounted so that any refrigerant released from the system during its operation can not cause harm to the user of the appliance. The aperture shall be located so that it is unlikely to be obstructed in normal use.
- · The installed pressure relief device shall have no provisions for setting by the end user.
- The pressure setting of the installed pressure relief device shall be no higher than the design pressure of the high-pressure side.
- For any fine-tune setting to the electronic valve parameters please refer to the service manual on the website.
- · In case of "Marine" models, the appliances must be fixed to the floor.
- Prevent the areas where the appliance is installed to be polluted with corrosive substances (chlorine, etc.). The manufacturer
  declines any liability for corrosive effects due to external causes.

#### A.16 Wall fixing

When installing the glass door appliances with high feet make sure to fix the anti-tipping cables to it.
 To fit proceed as shown in the paragraph E.6 Fitting anti-tipping cables on glass door models (2 module) with feet or wheels

#### A.17 Wheel rotation lock brackets

#### IMPORTANT

On all V2MMTNHC - V2MMTNMHC and V2MMTN models with high wheels, install the wheel rotation locking bracket accessory included in the appliance, according to the installation instructions.

#### A.18 Appliance space limitations

Appliances with standard ventilation: make sure to position the appliance at least 500 mm from the top, 30 mm from the back, 20 mm (for refrigerated models) and 30 mm (for freezer models) from any other machines present in the room (in fact, close proximity can create problems of condensate forming on the walls of the appliance), also taking into consideration the space needed for door opening. For 3-doors models make sure to position the appliance at least 500 mm from the top, 100 mm from the back, 20 mm from any other machines present in the room. Appliances with frontal ventilation (Marine models): make sure to position the appliance at least 105 mm (for 1MTN-2MTN models) and 200 mm (for 2MBT model) from the top, 30 mm from the back, 20 mm from any other machines present in the room.

#### A.19 Appliance disposal

 Make the appliance unusable by removing the power cable and any compartment closing devices, to prevent the possibility of someone becoming trapped inside.

Operator for normal appli- ance use	an operator who has been informed and trained regarding the tasks and hazards involved in normal appliance use.
Customer Care service or specialised personnel	an operator instructed/trained by the Manufacturer and who, based on his professional and specific training, experi- ence and knowledge of the accident- prevention regulations, is able to appraise the operations to be carried out on the appliance and recognise and prevent any risks. His professionalism covers the mechanical, electrotechnical and elec- tronics fields etc.
Danger	source of possible injury or harm to health.
Hazardous situation	any situation where an operator is exposed to one or more hazards.
Risk	a combination of probabilities and risks of injury or harm to health in a hazardous situation.

- repairs not carried out in a workmanlike fashion, and replacements with parts different from those specified in the spare parts catalogue (the fitting and use of non-original spare parts and accessories can negatively affect appliance operation and invalidates the original manufacturer warranty);
- operations carried out by non-specialised personnel;
- unauthorized modifications or operations;
- missing, lack or inadequate maintenance;
- improper appliance use;
- · unforeseeable extraordinary events;
- use of the appliance by uninformed and / or untrained personnel;
- non-application of the current provisions in the country of use, concerning safety, hygiene and health in the workplace.

The Manufacturer declines any liability for damage caused by arbitrary modifications and conversions carried out by the user or the Customer.

The employer, workplace manager or service technician are responsible for identifying and choosing adequate and suitable personal protection equipment to be worn by operators, in compliance with regulations in force in the country of use.

The Manufacturer declines any liability for inaccuracies contained in the manual, if due to printing or translation errors.

Any supplements to the installation, use and maintenance manual the Customer receives from the Manufacturer will form an integral part of the manual and therefore must be kept together with it.

#### C.7 Customer packaging checks

- The forwarder is responsible for the goods during transport and delivery.
- Make a complaint to the forwarder in case of visible or hidden damage.
- Specify any damage or shortages on the dispatch note.
- The driver must sign the dispatch note: the forwarder can reject the claim if the dispatch note is not signed (the forwarder can provide the necessary form).

#### After packaging checks

#### D.1 Materials and fluids used

The areas in contact with the product are in steel or coated with non-toxic plastic material. The fluorinated gases are contained in a hermetically sealed device. An HFC (R134a(GWP:1430)/

R404a(GWP:3922)/R407a(GWP:2107)) or HC refrigerant fluid for models with refrigerant R290, complying with the current regulations, is used in the refrigerating units. The type of gas used is given on the data plate. The CO2 equivalent of the gas may be calculated multiplying GWP value by quantity of gas.

#### E INSTALLATION AND ASSEMBLY

#### E.1 Introduction

Refer to "Warning and Safety Information".

To ensure correct operation of the appliance and maintain safe conditions during use, carefully follow the instructions given in this chapter.

Check and, if necessary, level the appliance after positioning. Incorrect levelling can cause appliance malfunctioning.

#### CAUTION

Before moving the appliance make sure the load bearing capacity of the lifting equipment used is suitable for its weight.

#### NOTE!

Appliances with incorporated refrigerating unit must be handled upright. If the appliance is handled in a horizontal position, make sure to wait a few hours in upright position before making it operational.

#### CAUTION

- Install the appliance in a ventilated place, away from heat sources such as radiators or air conditioning systems, to allow correct cooling of the refrigerating unit components.
- Never cover the condenser, even temporarily, as this can compromise its proper operation and therefore that of the appliance.
- The machine must be taken to the place of installation and removed from the packing base only when being installed.

#### E.2 Customer's responsibilities

The tasks and works required of the Customer are:

- check the floor planarity on which the appliance is placed;
- arrange an earthed power socket of suitable capacity for the input specified on the data plate;
- provide a high sensitivity manual-reset differential thermal magnetic switch;



NOTE! For information regarding the electrical connection, refer to "A.11 *Electrical connection*".

#### E.3 Unpacking instructions

## Unpack the appliance carrying out the following operations:

- if present, cut the straps and remove the protective film, taking care not to scratch the surface if scissors or blades are used;
- if present, remove the cardboard top, the polystyrene corners and the vertical protection pieces;
- for appliances with stainless steel surfaces, remove the protective film very slowly without tearing it, to avoid leaving glue stuck to the surface;
- should this happen, remove the traces of glue with a noncorrosive solvent, rinsing it off and drying thoroughly;
- it is advisable to go over all the stainless steel surfaces with a rag soaked in paraffin oil in order to create a protective film.

#### E.4 Disposal of packing

The packing must be disposed of in compliance with the current regulations in the country where the appliance is used. All the packing materials are environmentally friendly.

They can be safely kept, recycled, or burned in an appropriate waste incineration plant. Recyclable plastic parts are marked as follows:

The parts in wood and cardboard can be disposed of, respecting the current regulations in the country where the appliance is used.

## E.5 Positioning

Install the appliance, taking all the safety precautions required for this type of operation, also respecting the relevant fireprevention instructions.

If the machine is installed in a place where there are corrosive substances (chlorine, etc.), it is advisable to go over all the stainless steel surfaces with a rag soaked in paraffin oil to create a protective film.


Arranging the machine:

- adjust the height and levelling with the adjustment feet, also checking correct door closing.


# E.6 Fitting anti-tipping cables on glass door models (2 module) with feet or wheels

When installing the appliance, make sure to fix the anti-tipping cables to it. To fit, proceed as follows:


 undo the two Phillips screws securing the bracket to the rear side on the roof of the machine, as shown in the figure;




2. remove the cables from their packing;



3. join a slot of the cable to the screw;



4. retighten the screw complete with the cable on the roof of the appliance;



- 5. the cable must then be fixed to the wall with a plug, to permanently secure the appliance;
- 6. Repeat the same operation also with the other cable.


#### E.7 Plumbing connection



#### CAUTION

The plumbing connection must be carried out by a specialised personnel.

The machine has a drain hole for any liquids present in the compartment. Connect the compartment drain hole "D", located on the bottom of the appliance and provided with a closing plug, to a drain. The drain hole diameter is "17.5 mm", therefore it is advisable to connect it to a "17.5 mm" drain pipe.



# E.8 Reversing opening of fully insulated doors



#### CAUTION


The user cannot reverse the door opening direction in all models with glass door. Models with glass door come with opening from left to right. To reverse the opening direction in refrigerated models, call the Customer Care Service.

Single- door refrigerated cupboards are normally supplied with right opening. When converting to left opening, proceed as follows:

open the control panel, loosening the 2 screws located between the panel and door;


- undo the 2 fixing screws of bracket "A" and the screw securing hinge "B" (detail 1);
- remove the door and remove hinge "B" from right to left, break the precut "F" on the opposite side and insert part "B" (detail 6) and the bracket as shown in the figure;
- remove the lower bracket "D", refitting it in the special seat on the opposite side (detail 2);
- · position the door on the lower bracket "D";

- position the upper bracket "A" between the door and the roof of the appliance, tightening the fixing bolts;
- before tightening the screws, align the door with the panel of the cabinet, adjusting the lower and upper brackets and making sure the seal is perfectly fitted on all sides;
- then tighten the bracket fixing bolts.

#### E.9 Reversing opening of half doors

The refrigerated cupboards are normally supplied with right opening.

The operations to be carried are those described in the previous section, replacing reference "D" with "F" (detail 3)


- open the control panel, loosening the 2 screws located between the panel and door;
- undo the 2 screws fixing bracket "A" and the screw securing hinge "B" of the top door;
- remove the door and remove hinge "B" from right to left, break the precut "F" on the opposite side and insert part "B" (detail 6) and the bracket as shown in the figure;
- remove the middle bracket "G" (detail 4) and fix it on the opposite side of the cabinet remove the lower bracket "D", refitting it in the special seat on the opposite side (detail 5);

- · position the bottom door on the lower bracket "D";
- fix the middle bracket "E";
- · position the top door on the middle bracket "G";
- position the upper bracket "A" between the door and the roof of the appliance, tightening the fixing bolts;
- before tightening the screws, align the door with the panel of the cabinet, adjusting the lower and upper brackets and making sure the seal is perfectly fitted on all sides;
- · then tighten the bracket fixing bolts.

NOTE!

After carrying out the below operations, the holes in the appliance must be closed with the special plastic plugs.

In case of installation on a concrete plinth, make 2 holes in the floor near the bottom hinge fixing screws.
